Executive Committee Recommendations

Executive Committee members reported that they met on May 15th to review the current budget and draft a budget for FY26. The committee recommended the following to the board:

- FY25 Budget
 - o Provide up to \$16,500 in items/supplies for child care providers (licensed centers and registered home) utilizing a formula (base amount by type of provider, enrolled in IQ4K and supports special needs children). Ms. Stanek will reach out to providers, collect their shopping list for the dollar amount allocated, place orders for each provider through Lakeshore Learning to be shipped to the provider's place of business.
- FY26 Budget
 - Provide contracts to:
 - Your Own United Resources Head Start Transportation \$35,000
 - Calhoun County Public Health Family Foundations (Calhoun & Pocahontas) \$171,000
 - Preschool Tuition Assistance- Area preschools \$60,000.00 (total)
 - Unallocated funds will be planned for at a future meeting.

MOTION: Mr. George made the motion to approve the recommendations for the FY25 and FY26

budgets as recommended by the Executive Committee.

SECOND: Ms. Laufersweiler

Discussion: None

ACTION: Motion passed unanimously.

Child Care Project

Ms. Stanek provided an overview of the current state of the child care project, meetings/work that had been attended/completed, available funding, contracting requirements of the grant we have received and potential next steps. The board held a discussion on how to move forward as well as roof type (flat membrane vs traditional truss/shingle).

MOTION: Mr. George made the motion to secure bids for a roof replacement using the project plans/specs.

SECOND: Ms. Laufersweiler

Discussion: In order to move the project forward, the board may need to solicit bids for all trades. Mr. George will visit the project site and review plans for alternatives.

ACTION: Motion passed unanimously
